- Board members and positions
  - o Reviewed bylaws regarding voting, terms. Board can select someone to fill vacancy for the remainder of term.
    - Rick voted interim treasurer unanimously
    - Rick will retain president role until next election in April
  - o Taylor requested bank account co-signer capability
    - Remove Cindy as a co-signer
- Non-profit status
  - o Rick moved non-profit status over "Public charity" from "private foundation", to make tax reporting easier (with the postcard).
- Whitefeather financials / tourney
  - o \$1,117 from tourney after payouts
  - o Loomis Cabin au gratis
- Course maintenance before the end of the year
  - o Tee signs
  - o Weed whacker at Hole 2 - Lincoln Park
  - o Lincoln Park lettered holes - move tree debris out of the way, weed whack
  - o Alt tee pads for all letter holes
    - B / F alt tee pad already sited
  - o Mower (Jeff)
    - Unknown yet if able to store it in the shed at the park
  - o Cement tee pads for lettered holes

- OPDGA Financials
  - Big money dubs and singles - \$250 in 2025 to date
  - Currently \$8,921.61 in reserve
  - Bryce - keep track of sponsorship expiration on baskets
    - Offer discount on renewals
- Heads and Beds grant through City of Port Angeles
  - Jeff - Hotels / campgrounds / BnBs charged a higher tax rate. Money distributed by a board to things that will bring in tourism to the community.
  - Two different types of grants:
    - Operating expenses cover
    - Single event cover
  - What they're looking for:
    - Marketing for out-of-area
    - Offseason tourists
    - Multi-night stays
    - October 12th is application deadline
  - Need Federal Tax ID, contact, itemized annual budget, description of how the grant will be spent, non-profit registration with WA Sec of State, website
- Glow league

  - Halloween tourney - weekend after Halloween because everything is cheaper

- Tee signs - Lincoln / RS
  - What type of signs?
